



Terms, Conditions, Release & Waiver for Minors (Under age of 18)

If the Volunteer is less than 18 years of age, the Volunteer and the parents having legal custody and/or the legal guardians of the Volunteer (the “Guardians”) also hereby release and forever discharge the Released Parties from any claim whatsoever which arises or may hereafter arise on account of the decision by any representative or agent of the Released Parties to exercise the power to consent to medical or dental treatment as such power may be granted and authorized in a Parental Authorization for Treatment of a Minor Child.

Volunteers ages 17 and under must have a current liability waiver signed by a parent or guardian. An adult supervisor **MUST** accompany anyone under the age of 18 years old and assume responsibility for youth compliance with the conditions below. Groups of minors must maintain at least a 1:4 ratio of adults to youth. Volunteers ages 14 and 15 can only assist with non-construction tasks such as landscaping and painting. In addition, they must agree not to use power tools not climb ladders more than 6 feet tall, and not work from heights (on a roof or on scaffolding) on constructions sites. Volunteers ages 16 and 17 can assist with landscaping, painting, clothing and donation sorting, and other minor tasks. They may never use motorized machinery and power tools, except power screw drivers with constant adult supervision. **ANYONE UNDER THE AGE OF 14** is not allowed to volunteer for construction projects, **BUT**, is able to volunteer for other functions.

As the parent or legal guardian of the below listed minor, hereby consent to and authorize the Minor to act as a volunteer for Austin Street Center. I acknowledge and agree that activities performed by the Minor as a volunteer will be performed strictly on a voluntary basis, without any pay, compensation, or benefits. I agree and understand that the Minor must comply with the rules and regulations established from time to time by Austin Street Center and that failure to do so may result in the Minor’s immediate removal as a volunteer.

I am aware of the nature of the activities to be performed by the Minor as a volunteer and recognize that in performing volunteer tasks, a risk of harm or injury exists. I agree that all volunteer activities are to be performed by the Minor at the Minor’s risk and I assume full responsibility therefore.

I grant and convey all right, title, and interests in any and all photographs, images, video or audio recordings of the Minor made by Austin Street Center in connection with the Minor while volunteering with Austin Street Center.

On behalf of myself, the Minor, and our respective heirs and personal representatives, I agree not to hold or attempt to hold Austin Street Center, their population served, volunteers, or staff responsible for any injury or damage sustained or incurred by the Minor, arising out of or in any way connected with the Minor’s activities as a volunteer for Austin Street Center. I hereby release and discharge Austin Street Center, their employees, and their volunteers from any and all claims, demands, causes of action of any nature or cause, for any such injury or damage incurred or suffered by the Minor.
