



VOLUNTEER TERMS, CONDITIONS, & WAIVER

In this event of my selection to volunteer at Austin Street Center, I, _____, will comply with all of the rules and regulations set forth by Austin Street Center. I further understand that the completion of a volunteer profile within Austin Street's volunteer management system does not guarantee my status as a volunteer. I must meet all stated conditions required of the position for which I am asking to be placed.

Moreover, information provided by a client or staff member to any volunteer is considered to be confidential and is subject to the terms of Austin Street Center's confidentiality policy. Confidentiality is defined as the assurance that unwarranted access to information regarding a client shall be protected from improper disclosure. I understand that any violation of this policy shall be considered breach of faith. I understand that any violation of this policy is grounds for termination of my volunteer relationship with Austin Street Center.

I further understand that in the event I volunteer with Austin Street Center, all volunteers are subject to dismissal at the discretion of Austin Street Center. If, in the event I choose to cease volunteering, I am free to do so at any time.

I hereby release Austin Street Center from all actions, claims, or demands that I or my representatives now have or may hereafter have for injury, death, or damage to myself and/or my property resulting from my participation in Austin Street Center's volunteer activities. This includes actions, claims, or demands resulting in whole or in part from the negligence of Austin Street Center or its directors, officers, agents, employees, or volunteers. I attest that my attendance and involvement in volunteer activities at Austin Street Center is voluntary, that I am participating at my own risk.

I also hereby grant permission to Austin Street Center to the rights of my image, likeness and sound of my voice as recorded on audio or videotape without payment or any other consideration. I understand that my image may be edited, copied, exhibited, published, or distributed and waive the right to inspect or approve the finished product wherein my likeness appears. Additionally, I waive any right to royalties or other compensation arising or related to the use of my image or recording. I also understand that this material may be used in diverse settings within an unrestricted geographic area. I understand this permission signifies that photographic or video recordings of me may be electronically displayed via the internet or on television.
